

SUBJECT: Redelegation of Authority to Grant Waivers from the Requirement to Accept  
Electronic Funds Transfer Payments Within the Department of Defense

The Deputy Secretary of Defense, in a memorandum dated January 14, 2000, (subject: Implementation of Title 10, United States Code, Chapter 165, Section 2786), delegated to the Under Secretary of Defense (Comptroller) the authority to determine when individuals (including sole proprietors) may be exempted from the requirement to accept payment by electronic funds transfer. That memorandum also authorized the Under Secretary of Defense (Comptroller) to redelegate this waiver authority in writing.

I hereby delegate to the Director, Defense Finance and Accounting Service (DFAS), the authority to grant the subject waivers. This authority may be redelegated. The Director, DFAS, shall develop implementing guidance for issuance in the appropriate volumes of the DoD Financial Management Regulation (DoD 7000.14-R).
